4. CRTPA DISCUSSION

A. Connections 2040 Regional Mobility Plan

The initial ranking of projects utilizing the prioritization process that was approved at the February 9, 2015 CRTPA meeting will be presented along with the revenue estimates for the Connections 2040 Regional Mobility Plan.

Artie White, Kimley-Horn and Associates, provided information regarding the initial ranking of the projects for the Connections 2040 Regional Mobility Plan (RMP) and outlined the public involvement process the project has gone though. He stated public meetings were held in all of the counties and noted there was an additional meeting held by the Agency for Persons with Disabilities. Mr. White outlined the categories within the RMP Opportunities Plan. Mr. Kostrzewa stated there would be corrections made to the list to remove projects that have already been completed, projects under \$300,000, duplicate projects, resurfacing and paving projects, bridges, and projects that are funded but not yet constructed. Mr. Kostrzewa emphasized that the Opportunity Plan projects are ranked to determine how well the projects meet the Evaluation Criteria and not how projects should be ranked for completion. He continued to state that the results of the application of the criteria would be the Needs Plan. He noted if there were changes to criteria that the June 2015 adoption of the plan would be in jeopardy. Mr. Mikyska noted, the list is a tool and doesn't have to be followed exactly as it is printed. He noted, the moving of the projects within plan is within the authority of the Board. Lastly, he noted, depending on funding eligibility and funding partnerships, there may be projects moved ahead of others.

The board provided comments on criteria and the prioritization of the projects. The consensus of the majority was to not delay the plan adoption. Commissioner Nick Maddox stated the Board should consider hosting additional meeting to ensure the June deadline is met. Commissioner Desloge stated he was hesitant to stop at this point in the process. Commissioner Scott Maddox stated the Board should move forward with the plan.

FISCAL YEAR (FY) 2017 – FY 2021 TRANSPORTATION ALTERNATIVES (TA) PRIORITY PROJECT LIST (PPL)

REQUESTED BY: CRTPA Staff

Type of Item: Discussion

STATEMENT OF ISSUE

Staff is seeking CRTPA approval of the Fiscal Year (FY) 2017 – FY 2021 Transportation Alternatives (TA) Priority Project List (*Attachment 1*). The TA PPL identifies projects that expand travel choices including on-road and off-road trail facilities for pedestrians, bicyclists, and other non-motorized forms of transportation, recreational trail programs, safe routes to school projects as well as projects that seek to construct boulevards on certain types of eligible roadways. Projects on the CRTPA TA PPL are solicited every two (2) years throughout the CRTPA region by the CRTPA. The projects on this year's list were solicited in 2014.

RECOMMENDATIONS BY CRTPA COMMITTEES

On March 3, 2015, the CRTPA's two (2) committees (Citizens Multimodal Advisory Committee and Technical Advisory Committee) recommended CRTPA <u>approval</u> of the DRAFT FY 2017- FY 2021 Transportation Alternatives Priority Project List.

RECOMMENDED ACTION

Option 1: Adopt the FY 2017-FY 2021 Transportation Alternatives Priority Project List.

HISTORY AND ANALYSIS

Transportation Alternatives are programs and projects, including on- and off-road pedestrian and bicycle facilities, infrastructure projects for improving non-driver access to public transportation and enhanced mobility, community improvement activities, and environmental mitigation; recreational trail program projects; safe routes to school projects; and projects for the planning, design or construction of boulevards and other roadways largely in the right-of-way of former Interstate System routes or other divided highways.

The creation of the Transportation Alternatives Program occurred in 2012 as result of the passage of the Moving Ahead for Progress in the 21st Century Act, known as MAP-21 (the federal funding and authorization bill that governs federal surface transportation spending). Associated with MAP-21 was the establishment of the Transportation Alternatives Program (TAP) providing funding for programs and projects defined as transportation alternatives.

The Transportation Alternatives Program combined several existing (and separately funded) federal programs into one program. Specifically, the Transportation Enhancements, Safe Routes to School and Scenic Byways Program were consolidated into the TAP. In light of this change, many of the projects formerly funded solely under the CRTPA's former Transportation Enhancements program now compete for funds with other types of projects that were consolidated into the TAP.

CRTPA 2015 TA Schedule

In a letter dated January 22, 2015, the FDOT District 3 provided guidance related to the submittal of TA projects for FY 2017 – FY 2021 funding consideration. Included within this guidance was a request that the CRTPA submit a prioritized listing to the FDOT by May 1, 2015. As a result, this year's CRTPA TA PPL is being adopted earlier than the typical September date. This earlier date is due to the earlier start (January 2016) of the upcoming Florida Legislative session. Note: The remaining CRTPA PPLs are also scheduled to adopted earlier (at the June 29, 2015 CRTPA Board meeting).

Draft FY 2017 - FY 2021 TA PPL

The Draft FY 2017 – FY 2021 TA PPL maintains the same project order as last year's adopted (FY 2016 – FY 2020) TA Priority Project List with the exception of the following updates made to the list:

- PROJECT REMOVAL: Last year's number two (2) ranked project (<u>Adams Street Sidewalk</u> in Quincy) was removed from the list due to the project receiving full funding in the most recent (Draft FY 2016 – FY 2020) Work Program.
- PROJECT UPDATE: Last year's number one (1) ranked project (<u>Glenview Drive Sidewalk</u> in Tallahassee) has been updated to reflect the need for construction funding (design funding was received for FY 18 in the most recent work program).

NOTE: Consistent with Board direction, solicitation of new TA projects occurs biennially. The projects on this year's TA PPL were originally solicited and ranked in 2014. The next solicitation of new TA applications will occur next year (in early 2016). As discussed below, the CRTPA is allocated approximately \$310,000 annually. The total amount of funding requested by the projects included on this year's Draft TA PPL is approximately \$7.1 million.

CRTPA TRANSPORTATION ALTERNATIVES PROGRAM BACKGROUND

As a result of the changes associated with MAP-21 (the federal funding and authorization bill that governs federal surface transportation spending) in 2012, the CRTPA's Transportation Alternatives Program (TAP) was established in 2013 to replace the agency's former Transportation Enhancements (TE) program. Specifically, at the March 25, 2013 CRTPA Board meeting, members approved establishment of the CRTPA's TAP and an associated schedule for program implementation.

One of the first tasks involved the creation of the CRTPA TA Subcommittee. The subcommittee, comprised of 6 members (3 from the CRTPA's Citizens Multimodal Advisory Committee and 3 from the Technical Advisory Committee), was tasked with (1) identifying evaluation criteria to rank the TA applications and, (2), reconvening in the spring of 2014 to score the CRTPA's TA applications using the approved evaluation criteria.

On November 18, 2013 the CRTPA approved the evaluation criteria developed by the subcommittee to use in ranking the TA applications. Specifically, the following criteria were approved:

Public benefit versus project cost (To what extent will the project benefit the community or region?)	5

In January 2014, a call for TA applications was formally made by the CRTPA and a total of ten (10) TA applications were received for TA funding consideration, as follows:

APPLICATIONS RECEIVED

TOWN OF HAVANA: <u>Havana Middle School Sidewalks</u> (Limits: 11th Avenue (4th Street to Iron Bridge Road); Iron Bridge Road (CR 12A to 11th Avenue); .67 miles; \$400,000

CITY OF QUINCY: Adams Street (CR 268) Sidewalk Construction (Limits: Clarke Street to MLK Jr Blvd); .57 miles; \$368,000. (NOTE: THIS PROJECT HAS BEEN FULLY FUNDED AND HAS BEEN REMOVED FROM THE UPDATED TA PPL)

JEFFERSON COUNTY: Old Lloyd Road (CR 158A) Shoulder Paving Project (Limits: US 90 to SR 59); 8.9 miles; \$1.8 million.

JEFFERSON COUNTY: Waukeenah Highway (CR 259) Shoulder Paving Project (Limits: US 19 to US 27); 9.4 miles; \$1.9 million.

CITY OF ST MARKS: <u>St. Marks Trail Southern Extension</u> (Limits: Trail's southern terminus to St. Marks Riverfront Park); .39 miles; \$724,044.

CITY OF ST MARKS: Wakulla Coast Charter School Sidewalk (Limits: Port Leon Drive (Terminal Drive to Shell Island Road); Shell Island Road (Port Leon Drive to Wakulla Coast Charter School); .26 miles; \$921,000.

CITY OF TALLAHASSEE: Glenview Drive Sidewalk Project (Limits: Thomasville Road to Meridian Road); .36 miles; \$350,000. (NOTE: DESIGN FUNDING HAS BEEN RECEIVED)

WAKULLA COUNTY: <u>US 98/Panacea Community Sidewalk</u> (Limits: n. of Clark Drive to n. of Piney Street); .4 miles; \$209,000.

WAKULLA COUNTY: Mound Street/Panacea Community Sidewalk (Limits: US 98 to Wooley Park); .13 miles; \$114,000.

WAKULLA COUNTY: Otter Lake Road/Panacea Community Sidewalk (Limits: US 98 to Fishing Fool Road); .5 miles; \$252,000.

The TA Subcommittee conducted an interview with representatives of each of the above applications on May 21, 2014. The interviews allowed applicants an opportunity to discuss their projects as well as answer questions of subcommittee members.

As noted above, with the exception of the above identified changes, the Draft FY 2017 – FY 2021 maintains the project rankings of last year's TA PPL.

TA FUNDING AVAILABILITY

Approximately \$310,000 of Transportation Alternatives funding is dedicated annually for the CRTPA region (Gadsden, Jefferson, Leon and Wakulla counties).

In addition, other TA funding is available for placement on projects within the CRTPA region. This funding, which is outside of the approximately \$310,000 dedicated to the CRTPA, is placed on projects at the discretion of FDOT District 3.

PUBLIC INPUT

A public meeting to receive input on the Draft FY 2017 – 2021 TA Priority Project List was held on April 2, 2015 in Tallahassee City Hall. Information regarding the meeting was placed on the CRTPA's website (www.crtpa.org) and an e-mail message regarding the meeting was sent to the agency's transportation partners. Public meetings related to the CRTPA's remaining PPLs, scheduled for adoption on June 29, will be scheduled in Gadsden, Jefferson, Leon and Wakulla counties in June.

NEXT STEPS

As noted above, typically, the TA PPL (and other CRTPA PPLs) is adopted in September of each year. However, due to next year's (2016) Florida Legislative Session beginning in January, the date for all priority project lists to be provided to the FDOT has been moved up to August 10, 2015. As a result, the remaining CRTPA FY 2017 – FY 2021 PPLs are scheduled to be adopted at the June 29, 2015 CRTPA meeting.

Subsequent to adoption of the CRTPA FY 2017 – FY 2021 PPLs, the lists will be provided to the FDOT for use as the agency proceeds with development of the Draft FY 2017 – FY 2021 Annual State Work Program.

The Draft Annual State Work Program is currently scheduled to be presented to the CRTPA Board by the FDOT at the October 19, 2015 CRTPA Retreat. Subsequent to release of the Draft State Work Program, CRTPA staff will initiate development of the CRTPA FY 2017 – FY 2021 Transportation Improvement Program (TIP) incorporating those transportation projects in the CRTPA region that have received state and federal funding.

CONNECTIONS 2040 REGIONAL MOBILITY PLAN (RMP) FINAL NEEDS PLAN AND DRAFT COST FEASIBLE PLAN

REQUESTED BY: CRTPA Type of Item: Discussion/Approval

STATEMENT OF ISSUE

The purpose of this item is to discuss the process that the Project Team utilized to move from the Needs Plan that was presented at the March 9, 2015 CRTPA Board meeting to the Draft Cost Feasible Plan being presented today.

CRTPA COMMITTEE ACTIONS

The CRTPA's two (2) committees (Citizens Multimodal Advisory Committee and Technical Advisory Committee) were scheduled to meet on April 14, 2015. Due to the tight deadline associated with distribution of the CRTPA agendas, the committee recommendations for this and other agenda items will be provided under separate cover prior to the meeting.

HISTORY AND ANALYSIS

There are several steps that occurred since the Draft Needs Plan was presented at the March 9, 2015 CRTPA Board meeting. These steps are briefly described below with further detail provided on following pages:

- 1. The Project Team extended the window to accept projects from CRTPA members to include in the Opportunity Plan. This window was extended until March 16, 2015. After these projects were received they were evaluated to determine where the project should be placed, e.g., the Duplicate Project List, Under \$300,000 List, Needs Plan etc...
- 2. After the projects were evaluated and placed in their respective list, the Needs Plan projects were reviewed to ensure the limits, status, and the points that were assigned via the Evaluation Criteria were correct. Based on additional comments from the Citizens Multimodal Advisory Committee, bike lanes, sidewalks, and shared-use paths were further evaluated for Universal Accessibility and the SouthWood Development Order was reviewed for project commitments.
- 3. The Project Team began the process of developing costs for each project on the Needs Plan list. After the costs were developed, the Project Team reviewed the costs and further refined the project list due to issues of costs for the inclusion of bike lanes.
- 4. With the project cost phase completed, the Project Team developed the Draft Cost Feasible Plan.

I. Additional Opportunity Plan Projects

At the March 9, 2015 CRTPA Board meeting, members voiced concern about not having enough time to include projects into the Opportunity Plan. Based on those concerns, additional time was provided for CRTPA members to add, delete or alter projects in the Opportunity Plan. These changes are shown in *Attachment 1*. The projects were evaluated to determine where they should be placed based on the project identification process that was originally used for the Opportunity Plan (presented at the March 9, 2015 CRTPA meeting). These locations could be:

- 1. Bridge, Resurfacing, Existing Sidewalks, Paving, Paved Shoulders, Sharrows, Bike Routing, Railroad Crossings, Railroad, Crosswalks, Drainage, Stormwater, Ineligible Trail projects,
- 2. Duplicate Projects,
- 3. Funded Projects,
- 4. Completed Projects,
- 5. Projects Under \$300,000 projects,
- 6. Transit Projects, or
- 7. Needs Plan

Attachment 1 also includes where each project ultimately ended up based on the Project Team evaluation. In total 218 projects were added to the Opportunity Plan with 133 projects being ineligible, 2 projects being duplicate, 74 projects added to the Projects Under \$300,000 list and 9 projects being added to the Needs Plan.

II. Needs Plan Review

Evaluation Criteria Point Adjustments

There were a couple of projects that had points adjusted based the Evaluation Criteria. Specifically, three projects should have had points on the Bike and Pedestrian Needs Plan because of a completed PD&E study (50 points added to each projects) and one with the PD&E Study underway (25 points added to project). These projects are in included:

Universal Accessibility

In addition to adjusting for Phase Completed, the Bike and Pedestrian list was re-evaluated for Universal Accessibility. The Universal Accessibility Evaluation Criteria was intended to evaluate a facility against how many user types (bike, pedestrian, handicapped, elderly, etc...) could use that facility. Originally, bike lanes were given 60 points because the facility provided another "mode" along a corridor. However, a bike lane is not intended to provide for pedestrian, handicapped, or elderly access, although it could be used for any of those users. In terms of a hierarchical approach to accommodate users, a shared-use path has the highest level and would be provided 60 points if it is connecting to at least one existing sidewalk or another shared-use path. A total of 40 points would be provided to shared-use paths with no external connections to existing shared-use paths or sidewalks, and bike lanes would be provided 0 points for Universal Accessibility.

SouthWood Projects (Bike and Pedestrian and Roadway)

During the development of the Opportunity Plan, the intention was to add all projects from the region into the process. Some projects, such as the SouthWood trail system or the access roads to SouthWood are the responsibility of the developer of the project as outlined in the Development Order or "DO". In the case of the SouthWood Trails and Southwood Plantation Road (Apalachee Parkway to Biltmore Avenue), they are the responsibility of the developer and therefore all of the trail projects and the road project were removed from the respective Needs Plan. Intersections (Roadway)

In general, local intersections are not considered in the long range transportation plan since there are other funds to that can be pursued address these issues. Additionally, many intersection improvements are operational and short-term in nature. Historically, including such projects in a long range transportation plan hasn't produced a funded improvement. However, there are some intersections such as flyovers, arterial roundabouts, or arterial intersections that make take a while to study, fund and complete. If there were projects in the Needs Plan that had improvements at the intersection of local roads, they were removed. These should be considered for Transportation System Management (TSM) funds.

III. Project Costs

The next step in developing the Draft Cost Feasible Plan was to determine the cost of each project on the Needs Plan for Bike and Pedestrian and Roadway. There are several steps in developing the cost for each project. These steps are outlined below.

FDOT Roadway Construction Cost Estimates (Urban and Rural)

Each FDOT district has different estimated costs for projects that are directly related to projects in the respective district. The cost estimates that were utilized for road projects are shown in **Attachment 2**. The cost of each specific type of improvement was then multiplied by the length of the project for roads, bike, and pedestrian projects.

Right-of-way

Right-of-way (ROW) costs are always difficult to determine for any project but estimates are still required. Therefore, the estimated ROW costs is \$2/square foot in rural areas (approximately \$87,000 per acre) and approximately \$10 million per mile for urban widening. These costs were based upon recent experience and provide a general estimate of costs. The assumption was a widening project would require 60 additional feet of ROW for each two lanes added.

Study, Design, Contingency and CEI

Any project that requires a Project Development and Environment (PD&E) Study and/or Design had an additional cost calculated that equated to 20% of the construction cost of the project. Lastly, to account for contingency and construction, engineering and inspection (CEI), an additionally 15% of all costs was calculated into the project.

FDOT Sidewalk and Shared-Use Path Construction Cost Estimates

For bike and pedestrian facilities the costs are not as complicated as roadway projects in terms of the multiple types of facilities. Essentially, the project is either a sidewalk or a shared-use path. For a sidewalk improvement the estimated cost per mile is \$187,082 and for a shared-use path \$418,813. These costs are also shown on **Attachment 2**.

Bike Lanes

Technically, adding a bike lane can minimally consist of paint, however; when there isn't enough "road" to make a bike lane, the cost is difficult to determine. **Attachment 2** contains an estimated per mile cost for bike lanes (both sides of the road) at \$176,814. However, there are an even wider range of costs that would potentially have to be included in adding a bike lane such as tearing out curb and gutter, tearing out existing drainage, piping ditches, moving utilities, purchasing right-of-way, reducing the number of lanes to make a bike lane (not a CRTPA decision), tearing out existing sidewalks, rebuilding curb and gutter, repaving the road, etc...

These are a few of the issues that have to be considered when adding a bike lane. Some estimates, depending on location could exceed \$10,000,000 a mile.

Based on the difficulty on determining a cost for adding a bike lane, the Project Team is recommending that the bike lane projects be removed from consideration as projects in the Cost Feasible Plan. Further study should be conducted to determine where bike lanes are needed and

what the costs are associated with those projects. There is simply not enough time in the Regional Mobility Plan project window to complete this process.

The Bike and Pedestrian Needs Plan and the Roadway Needs Plan are shown as **Attachment 3** and **Attachment 4**, respectively.

In total, the cost of the Bike and Pedestrian Needs Plan is \$228,760,000 and the Roadway Needs Plan cost is \$2,467,000,000.

IV. Cost Feasible Plan

The Cost Feasible Plan (CFP) was also developed in several phases. Each of these phases is described below.

Time Period Tiers

The Project Team approached this effort by breaking the year 2040 project horizon into five-year increments. The first five-year increment is accounted for by the Transportation Improvement Program (TIP). The "Tiers" include; Tier 1 - 2016 through 2020 (TIP), Tier 2 - 2021 through 2025 (five years), Tier 3 - 2026 through 2030 (five years), and Tier 4 -2031 through 2040 (ten years).

Revenues

The revenues for the Connections 2040 Regional Mobility Plan were presented in March and are included below. Table 1 reflects the estimated CRTPA revenues and Table 2 are estimated Leon County Local Option Sales Tax revenues. Table 2 was updated based on the April 1, 2015 Blueprint 2000 meeting.

Inflation factors

All of the projects costs presented in the Needs Plan are in Present Day Cost or "PDC". As the projects begin to be matched against revenues the project cost will increase due to inflation, depending on what "Tier" the project can be theoretically funded.

All Long Range Transportation Plans in Florida are required to show Cost Feasible Plan costs in Year of Expenditure (YOE). Therefore, the PDC of all projects must be inflated to the respective "Tier" in the Cost Feasible Plan. However, since the exact year of expenditure is not known all 5 (five) of the inflation factors associated with a particular "Tier" are averaged and applied to each project in that "Tier" The inflation factors used for the Connections 2040 Cost Feasible Plan are shown in **Attachment 5.**

Draft Cost Feasible Plans (April)

Utilizing the Bike and Pedestrian Needs Plan, the Roadway Needs Plan, and the revenues estimates the Draft Bike and Pedestrian and Roadway Cost Feasible Plans are shown as **Attachment 6** and **Attachment 7**, respectively. In addition to the Cost Feasible Plans, staff has included the Draft Work Program, **Attachment 8**, which is "Tier 1". Staff is going to incorporate the Tier 1 projects into the Draft Cost Feasible Plans to demonstrate the "flow" of the projects through the plans.

Draft Cost Feasible Plans (May)

The Draft Cost Feasible Plans are the first look at the projects that can be potentially funded utilizing CRTPA funds, then Leon County Sales Tax funds. There are some adjustments that will need to be made based on the April 1, 2015 Blueprint 2000 Intergovernmental Agency meeting, as well as, breaking down the Tier 2 and Tier 3 projects into respective programming phases, i.e., Project Development and Environment (PD&E), Design, Right-of-way, and construction. This further refinement of the revenues may produce a better distribution of projects in Tiers 2 and 3. However, given the time limitations to produce these Draft Cost Feasible Plans, any adjustments that may occur and be provided at the May CRTPA Board meeting.

Blueprint 2000 April 1, 2015 Meeting

At the April 1, 2015 Blueprint 2000 Intergovernmental Agency (IA) meeting members were provided an overview of the infrastructure project allocations. These allocations differed from those presented the March 9, 2015 CRTPA meeting and will need to be adjusted for allocating to

the Draft Cost Feasible Plan based on Table 2 in this agenda. The estimated Blueprint 2000 revenues in March were estimated at \$650M and have been reduced to \$550M to reflect the project allocations as presented to the IA. The difference between the two revenue tables is due a change in the City of Tallahassee and Leon County sales tax revenues from \$150M in March to \$50M in April. These updated revenue allocations are not reflected in the **Attachment 6** and **Attachment 7**.

This talk was given at a local TEDx event, produced independently of the TED Conferences. In this talk, McMahon sets forth a compelling argument for the economic, psychological and social value of uniqueness. He explains that, in a global marketplace, well-educated workers, world-class infrastructure and the ability to turn ideas into commercial realities are all critically important to economic success—but the other critical, but often forgotten, element is "community distinctiveness." "Communities that can't differentiate themselves," McMahon observes, "have no competitive advantage."

- Letter of Interest for a State Infrastructure Bank (SIB) Loan –

Staff is preparing a letter of interest for a SIB loan to advance the construction of the trail along US 98 in Wakulla County from the St. Marks Trail to the intersection of US 98 & US 319. Currently, construction funds are programmed over 4 years beginning in FY17. With a SIB loan, the entire project from St. Marks to US 319 could be constructed at one time and not over 4 or 5 years one section at a time. The loan, if secured, would be paid back with the funds programmed in the outer years for the project. The consolidation of the project construction would be a significant cost savings over the individual segment construction. Should FDOT accept CRTPA's Letter of Interest (due May 29th), an invitation to submit an application would be issued on July 1st. Staff would then return to the CRTPA Board for confirmation to submit an application. Closing date for the invited application will be August 31st. FDOT would commence negotiation for the loan on November 30th. Funds would be made available July 1, 2016.

SUMMARY OF MPOAC JOINT MEETING OF THE GOVERNING BOARD AND STAFF DIRECTORS

On April 2, 2015, a joint meeting of the MPOAC Governing Board and Staff Directors was held at the Double Tree Hotel in Tallahassee. A complete agenda package can be seen at the web link below.

Highlights of the meeting included:

- Executive Director Position The announcement of a new Executive Director of the MPOAC to replace Howard Glassman who will be retiring the end of May after 20+ years as the Executive Director. The new Director will be Jeff Kramer pending background review and salary negotiations. Jeff has been working with the Center for Urban Transportation (CUTR) at USF in Tampa. He has been assisting the MPOAC under contract with a number of projects and assignments for a number of years.
- Allocation of Non-Recurring PL Funds Florida MPOs were notified at the January 22, 2015 MPOAC Staff Directors meeting that an additional \$1,130,891 million In non-recurring federal planning (PI) funds had become available for their collective or individual use. The FDOT asked the MPOAC membership to consider options for allocating the available non-recurring PI funds, providing the details for one allocation scenario that would distribute all or a portion of the funds to individual MPOs based on their share of Florida urbanized area population. An alternative suggestion was to apply some or all of the funds available to an MPOAC state study or activity benefiting all MPOs.

The MPOAC Policy and Technical Subcommittee met on March 6, 2015 in Orlando and recommended the distribution of \$1 million of the PL funds to the individual MPOs, based on their share of urbanized area population, and distribute the remaining \$130,891 to the MPOAC for the development and implementation of an MPOAC Strategic Plan. CRTPA's share of the distribution is \$14,564. The MPOAC Board approved this recommendation.

Agency Reports –

- **FDOT** Secretary Boxold spoke to the group and provided insight into the direction of the FDOT in the future. He wants to continue and strengthen the partnership with the state's MPO's realizing they play a huge role in transportation planning and development. He intends to begin visiting MPOs around the state to become more familiar activities in the various parts of the state. Jim Wood, FDOT State Transportation Development Administrator, discussed the continuing development and outreach on the Florida Transportation Plan and Strategic Intermodal Systems Plan. **FHWA** Provided an update on MAP-21 performance measure development and rulemaking. All are still in various stages of development and review.
- Florida Transportation Commission (FTC) Chairman Jay Trumbull provided an overview of the FTC (see below). He also said that as part of the 2015 priorities for the FTC, they want to become more engaged in learning about planning efforts of the MPOs in Florida.

The Florida Transportation Commission was created in 1987, under Section 20.23, Florida Statutes, to serve as a citizen's oversight board for the Florida Department of Transportation. The Commission is assigned to the Department for administrative and fiscal purposes; otherwise, it functions independently of the control and direction of the Department. Composed of nine Commissioners appointed by the Governor and confirmed by the Florida Senate for four-year terms, the Commission is required to meet at least four times per year. The Commission usually meets around seven times per year, in locations throughout the state in order to receive local input.

The Commissioners must represent transportation needs of the state as a whole and may not subordinate state needs to those of any particular area. The Commission is prohibited from involvement in day-to-day operations of the Department (e.g., consultant or contractor selection, specific projects, personnel matters, etc.).

The Commission's primary functions are to:

- Review major transportation policy initiatives or revisions submitted by the Department pursuant to law.
- Recommend major transportation policy to the Governor and Legislature (Commission has recommended policies related to public transit, funding, road jurisdiction, distribution of funds to Districts, etc.).
- Serve as an oversight body for the Department (<u>review performance</u>, <u>review work</u>
 <u>program</u>, <u>monitor highway safety</u>, monitor financial status, and review budget requests
 and long-range plan).
- Serve as an oversight body for transportation authorities and monitor and report on the
 efficiency, productivity and management of those authorities created under Chapters 343,
 348 and 349, Florida Statutes.
- Serve as nominating Commission in the selection of the Secretary of Transportation (Governor appoints Secretary from among three candidates nominated by the Commission).
- Transformation of Our State Pre-Construction Process Mr. Brian Blanchard, FDOT Assistant Secretary for Engineering and Operations presented "Transformation of Our Pre-Construction Process" and FDOT's "Statewide Innovators Team". The Florida Department of Transportation commissioned a study to provide an analysis of the impact of federal regulations and processing times for federally funded projects for the PD&E, Design and Construction Phases versus state funded only projects. The study concluded that the majority of time/cost savings was in the PO&E phase. It was also determined that overlapping the Design and PD&E phase provided additional time/cost savings. Little or no time/cost savings was found during the construction phase.

Federally funded projects sampled lasted between 1.8 and 3.5 times longer than state funded projects in the pre-construction phase (PD&E and Design). The Department reviewed the 5 year work program and found 44 projects that will be modified to state only funding. Work Program Instructions have been revised to reflect that each new PD&E / Design Project phase added to the Work Program must be evaluated for benefits of funding solely with state funds versus federal funds.

Association of Metropolitan Planning Organizations - Ms. Delania Hardy, Executive Director of the Association of Metropolitan Planning Organizations (AMPO) attended to make a presentation on recent AMPO initiatives and to provide a status report on Washington DC federal legislative activities. Efforts continue to more Congress to adopt a new funding authorization for transportation.
