PROJECT LIMITS

Multilane Reconstruction of S.R. 363 (Woodville Highway) from S.R. 263 (U.S. 319) Capital Circle to Paul Russell Road in Leon County.

- **Segment 4** - Woodville Highway from Capital Circle to Gaile Avenue
- **Segment 5** - Woodville Highway from Gaile Avenue to Paul Russell Road

PROJECT HIGHLIGHTS

Segment 4

- Widen Woodville Highway from 2 to 4 lanes, with buffered bike lanes, between Capital Circle and Gaile Avenue (1.5 miles)
- Add left-turn lane on Ross Road
- Replace strain poles with mast arms at Ross Road signalized intersection
- Re-construct St. Marks Trail
- Construct three dry retention stormwater ponds



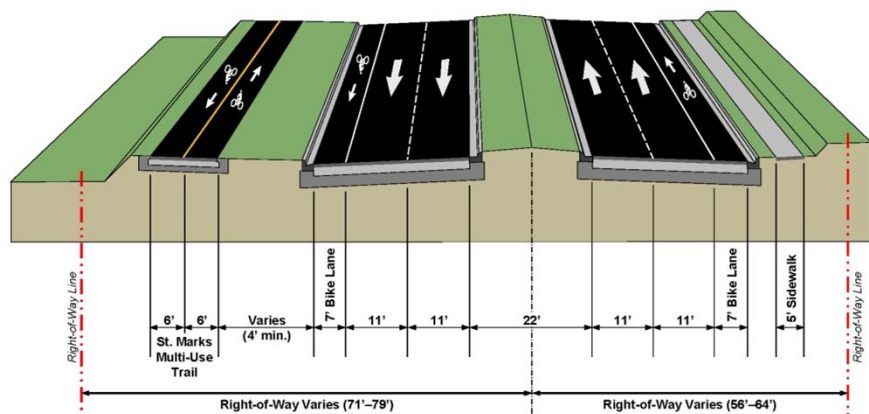
PROJECT HIGHLIGHTS

Segment 5

- Improve traffic operations in the Four Points area of Tallahassee, where Woodville Highway and Crawfordville Road converge
- Widen and extend Tram Road from 2 to 4 lanes
- Add buffered bike lanes on Woodville Highway and Crawfordville Road
- Construct traffic signals at Crawfordville Road & Gaile Avenue and Woodville Highway & Tram Road intersections
- Construct pedestrian-activated signals at Crawfordville Road & Tram Road Extension and Woodville Highway & Gaile Avenue intersections
- Re-construct St. Marks Trail
- Construct two dry retention stormwater ponds

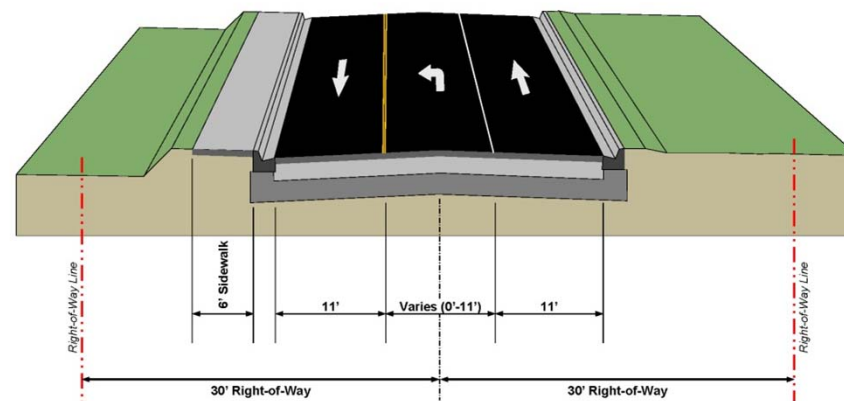
TYPICAL SECTIONS

TRAFFIC CONTROL

- A thorough Traffic Control Plan involving phase construction is being developed to ensure vehicular, bicycle, and pedestrian traffic will be maintained throughout construction
- Construct temporary St. Marks Trail
- Business access will be maintained throughout construction
- There will be no lane closures during peak hours or during special events
- Construction will be suspended during Springtime Tallahassee, Downtown Getdowns, the holiday parade, FSU & FAMU home football games, and the North Florida Fair

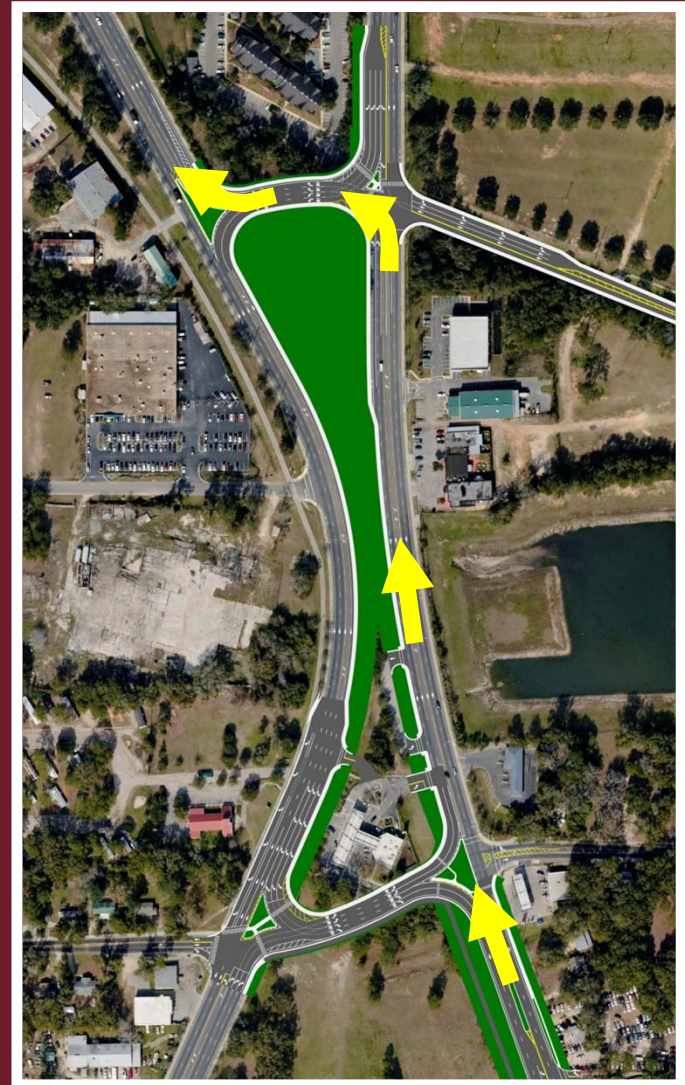

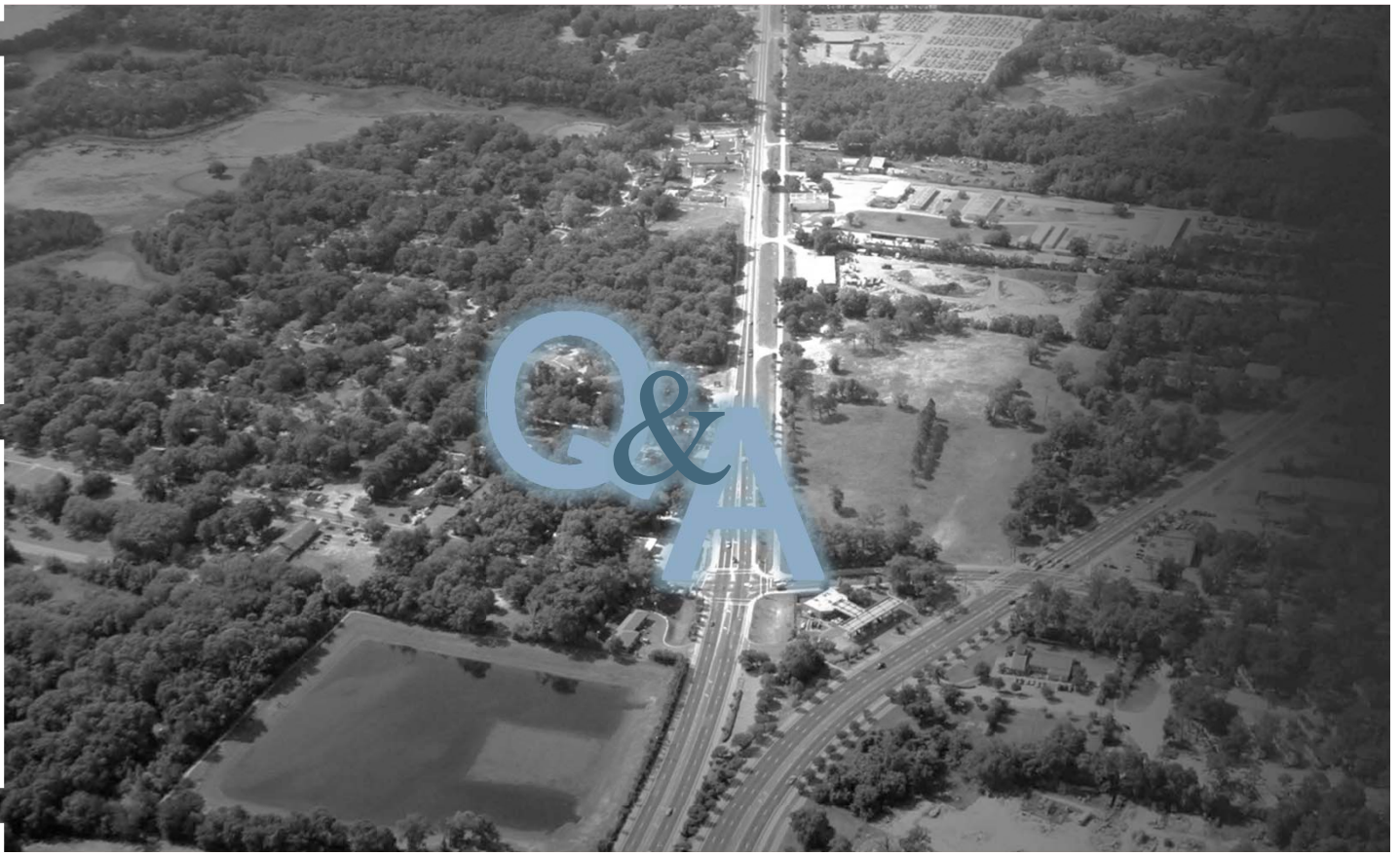
